Waltz Mill Safety Information

We want your visit to Waltz Mill to be as safe as possible. Please review the following safety information for the Waltz Mill Site and feel free to contact your sponsor should you have any questions.

- 1. Parts of Waltz Mill are active industrial areas, to include the Service Center, C-bay, D-bay, and some areas of the East Site. PPE requirements for entry include safety-toe footwear and safety glasses.
 - Safety toe footwear is not required for certain designated tours, but for any work, safety a. toe footwear is required in all industrial areas.
 - b. Safety glasses are available at all industrial area entrances.
 - Hardhats are also required if there is an overhead hazard; hardhats are available at or C. near entrances to industrial areas where they may be needed.
- 2. Certain areas of the Waltz Mill site handle radioactive materials, to include the Service Center and certain ancillary areas in G and P Buildings. Entry to into these areas, even for tours, is covered under a Radiation Work Permit (RWP), which will cover all radiation safety practices. Please see the brochure "Radiation Safety and Your Visit to the Waltz Mill Site". a.
- Upon hearing the fire alarm, immediately move to the closest exit door and leave the building. The fire alarm for most buildings at Waltz Mill consist of ringing bells and flashing strobes.

 - The EA and EB Buildings, on the Waltz Mill East Site, have electronic horns and strobes. b.
 - Remain outside until the "All Clear" announcement is made by the site PA system. C.
- 4. Report any injuries, no matter how minor, to your manager or supervisor. If you are a visitor, report any injuries to your site lead or sponsor. For emergencies, call the emergency telephone numbers listed below.
- 5. Safety Data Sheets (SDS) are available for all chemicals on site. Do not handle any chemicals unless you have been trained in handling them and have been authorized to do so.
- Ensure a safe path of travel while walking on site. Stay on sidewalks and designated pathways and avoid walking through grass or other unimproved areas.
- 7. The site speed limit is 15mph for all vehicles on all roads. Do not exceed the speed limit.
- 8. Obey all signs and postings. They convey important safety warnings and information.
- Certain activities in the Service Center involve high voltage electrical testing which may be hazardous to those with implanted pacemakers. Signs warning of this are posted on the entrance doors into the T Building. If you may be affected by this, please discuss with your site lead or sponsor.
- 10. Severe weather may impact the Waltz Mill site, such as thunderstorms, high winds, snowstorms, hot and cold temperatures, and occasional tornadoes. Ensure that you know the correct actions to take during any severe weather.
- 11. Waltz Mill is an ISO14001 certified site. Please do not improperly dispose of any waste materials and contact your manager or your sponsor (for any visitors) for additional environmental information.

Do not call 911 from a cell phone as the call will go directly to Westmoreland 911, potentially delaying emergency response on site.
